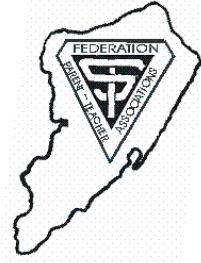

**Staten Island High Schools Scholarship Award Instructions for District 31,  
New Dorp High School, Gaynor McCown Expeditionary Learning School,  
Concord High School and District 75.**

Your school is to submit (10) applications to the Staten Island Federation of PTAs. If you do not have (10) Essay applications, a minimum of (6) essays are required in order for your school to be considered for a scholarship. If you have any questions regarding this requirement, please contact us immediately.

**College Advisor or School Designee:**

Every student in the January, June or August 2018 graduating class should be encouraged to apply. Please advertise the attached **Essay Flyer** to your student body.

The Essay Flyer and Student Information Sheet are attached and they may be printed and reproduced as needed. They can also be accessed on the Federation website at [www.sifpta.org](http://www.sifpta.org).

All essays are due to College Advisor or School Designee by **February 27, 2018.**

The College Advisor or School Designee is to BLIND all essays by **March 2<sup>nd</sup>**, place them in a sealed manila envelope marked **with your school's name** and make arrangements with the PTA President for pick up.

**PTA President:**

**If your school has more than ten (10) entries**, a selection committee is to be established by the school's PTA. The role of the selection committee is to select ten (10) essays to be forwarded for consideration to the Staten Island Federation of PTAs Scholarship Committee. The PTA President or their designee should be the chairperson of this committee, provided their child is not a senior. Selection must be based on the criteria established by the Staten Island Federation of PTAs. The High School PTA Selection Committee needs to read the entries between **March 6<sup>th</sup>** and **March 9<sup>th</sup>**. Your school's 10 essays are due to Federation by **Wednesday, March 14<sup>th</sup>**.

The Criteria is:

^ Written essay based on this year's essay theme;

^ Completed Student Information Sheet;

^ The **Essay recipient must be present** to receive the award on Tuesday, June 5, 2018.

The chosen Essays, along with their Student Information Sheets, are to be placed and sealed in a manila envelope, with the name of your school on the front and marked **D31 General Education or District 75 Entries.**

The PTA President must hand deliver the essay and Student Information Sheet to the Federation Office, by **Wednesday, March 14<sup>th</sup>**. **The Federation office is located in the Petrides Complex - 715 Ocean Terrace – Bldg. ## District 31 High School Special Education Scholarship Award Instructions [student receiving educational support services]

Each D 31 High School is to submit **one (1) application** to the Staten Island Federation of PTAs.

### College Advisor or School Designee:

Every District 31 special education student in the January, June or August 2018 graduating class should be encouraged to apply. Please advertise the attached Essay Flyer to your student body.

The Essay Flyer and Student Information Sheet are attached and they may be printed and reproduced as needed. They can also be accessed on the Federation website at [www.sifpta.org](http://www.sifpta.org).

All essays are due to College Advisor or School Designee by **February 27, 2018**.

The College Advisor is to BLIND the essay entries by **March 2<sup>nd</sup>**, place them in a sealed manila envelope marked **Special Education Entry** and make arrangements with the PTA President for pick up.

### PTA President:

A selection committee is to be established by the school's PTA. The role of the selection committee is to select one (1) District 31 Special Education student's essay to be forwarded for consideration to the Staten Island Federation of PTAs Scholarship Committee. The PTA President or designee should be the chairperson of this committee, provided their child did not apply. Selection must be based on the criteria established by the Staten Island Federation of PTAs. The High School PTA Selection Committee needs to read the Special Ed entries between **March 6<sup>th</sup>** and **March 9<sup>th</sup>** and deliver the selected (1) Special Education essay to the Federation Office by **Wednesday, March 14<sup>th</sup>**.

The Criteria is:

- ^ Written essay based on this year's essay question;
- ^ Completed Student Information Sheet
- ^ The Essay recipient must be present to receive the award on Tuesday, June 5, 2018.

The chosen essay, along with the Student Information Sheet, is to be placed and sealed in a manila envelope with the name of your school on the front and marked **Special Education Entry**.

The PTA President **must hand deliver** the essay and Student Information Sheet to the Federation Office, by **Wednesday, March 14<sup>th</sup>**. **The Federation office is located in the Petrides Complex - 715 Ocean Terrace – Bldg.
