

Notice of Joint Public Hearing for R880

The Proposed Grade Expansion and Two-Year Extension of the Temporary Co-location of Bridge Preparatory Charter School (84R076) with The Michael J. Petrides School (31R080) and The David Marquis School of the Arts (75R037) in Building R880 Beginning in the 2021-2022 School Year

A Joint Public Hearing will be held to provide the public with an opportunity to present comments or concerns on the proposal. The date, time, and location of the hearing is as follows:

This Joint Public Hearing will be an opportunity to learn more about potential changes to building R880 and share feedback.

The New York City Department of Education (NYCDOE) is proposing to extend the temporary colocation of Bridge Preparatory Charter School (84R076), referred to as Bridge Prep, for two years and expand the grades it serves in building R880 beginning in the 2021-2022 school yeaR880 is located at 715 Ocean Terrace, Staten Island, NY 10301 in Community School District 31, and houses grades 1-3 of Bridge Prep along with The Michael J. Petrides School (31R080), referred to as Petrides, an existing district school serving students in grades K-12 and offering a pre-kindergarten (pre-K) program; and The David Marquis School of the Arts (75R037), referred to as P037R@R880, one inclusion site of an existing multi-sited District 75 program serving students in grades K-5. R880 also houses the community-based organization (CBO) Police Athletic League (PAL).

A co-location means that two or more school organizations are located in the same building and may share common spaces, such as auditoriums, gymnasiums, libraries, and cafeterias.

Pursuant to a previous proposal approved by the Panel for Educational Policy (PEP) on April 17, 2019, the NYCDOE temporarily co-located Bridge Prep with Petrides and P037R@R880 in R880 for two years. As described in the previous proposal, the NYCDOE has been assessing available space in District 31 in an effort to identify a long-term siting option for Bridge Prep. Concurrently, Bridge Prep has been exploring opportunities to pursue private space. However, due to the COVID-19 crisis and its impact on construction and the use of buildings throughout New York City, alternative long-term siting options have not been identified for the 2021-2022 school year. As such, the NYCDOE is proposing to extend this temporary co-location for a period of two years to ensure current and future students at Bridge Prep can continue to be accommodated. Over the next two years, efforts will continue to identify a long-term siting option for Bridge Prep, which could include increasing instructional capacity on the Petrides campus or identifying an alternative NYCDOE building or private site. If this proposal is approved and alternative long-term space for Bridge Prep has not been identified for the 2023-2024 school year, the NYCDOE expects to extend the co-location at R880. Any future change in building utilization would be proposed in a separate Educational Impact Statement (EIS) and Building Utilization Plan (BUP), and be subject to separate approval by the PEP in accordance with Chancellor's Regulation A-190.
